1. EQUIPMENT DESCRIPTION

The Lessor agrees to rent to the Lessee the following equipment:

 - **Condition:** Equipment is provided in good working condition and inspected prior to release.

2. RENTAL TERM

3. RENTAL FEES

- **Weekly Rental Fee: \$550.00 USD**

- Rental fees are due **in advance** of equipment release.
 - Late returns may be charged an additional **\$100 per day** unless otherwise agreed in writing.

4. DAMAGE, LOSS, AND SURCHARGE

The Lessee assumes **full responsibility** for the equipment during the rental period.

- In the event of **damage, loss, theft, misuse, or destruction**, the Lessee agrees to pay a **surcharge equal to the full current replacement value of the Fluke Acoustic Imager II915**, as determined by the manufacturer's current market price at the time of loss or damage.
 - This surcharge applies **regardless of cause**, including accident, negligence, improper use, or environmental exposure.
 - Repair costs do **not** limit liability if the equipment is deemed non-repairable or unsafe for use.

5. USE OF EQUIPMENT

Lessee agrees to:

- Use the equipment only for its intended purpose
 - Operate equipment in accordance with manufacturer instructions
 - Allow only trained and competent personnel to operate the equipment
 - Not modify, disassemble, or tamper with the equipment

6. INSPECTION AND RETURN

- Lessee shall return the equipment **clean, complete, and in the same condition** as received, normal wear excepted.
 - BENSENA LLC reserves the right to inspect the equipment upon return and assess any damage or missing components.

7. INDEMNIFICATION

Lessee agrees to **indemnify and hold harmless BENSENA LLC** from any claims, damages, losses, injuries, or liabilities arising from the possession, use, or operation of the equipment during the rental term.

8. LIMITATION OF LIABILITY

BENSENA LLC shall not be liable for any indirect, incidental, or consequential damages arising from the use or inability to use the rented equipment.

9. TERMINATION

This Agreement may be terminated by BENSENA LLC immediately if Lessee breaches any term of this Agreement.

10. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the **State of Texas**, without regard to conflict-of-law principles.

11. ENTIRE AGREEMENT

This document constitutes the entire agreement between the parties and supersedes all prior oral or written agreements.
